

REGULATIONS OF PARTICIPATION in the 2nd LoveMed 2024 Polish Championships

CONDITIONS of participation in the Championship

1. An adult person who is qualified to perform a given procedure required in a given category of the championship, confirmed by a diploma, certificate or certificate of training completion, can take part in the Championship.

2. Applications will be accepted until the end of May 2023. The list of Finalists may be closed before the end of the application period if the maximum number of participants is reached, which is limited to 15 people per category.

3. The condition for participation is sending a properly completed application form and paying the fee for participation in the Championship.

4. Treatments that will be performed in the categories; Natural Lips, Russian Lips, Face Volumetry, Natural Beauty, can be performed

APPLICATION OF PARTICIPATION

1.1. Entry in each category requires completing the application form at www.lovedmed.pl

1.2. The participant may send an application to all categories, according to his or her experience and competences.

1.3. The application requires acceptance of the Regulations and the GDPR (the full content of the Personal Data Processing Agreement is available on the website www.lovedmed.pl)

4. The following documents should be attached to the Participation Form or application via e-mail in the form of photos/scans:

- diploma/certificate/certificate confirming completion of training authorizing to perform a given procedure, which will be required in a given category of the LoveMed24 championship
- 3 photos of your works without retouching from the selected area (lips, face,) before and after the procedure.

5. Information about qualifying for the LoveMed24 Polish Championships will be sent to participants by e-mail within 7 business days from the date of sending the application.

6. After receiving information about qualifying for the Championship, the participant has 3 business days to pay the fee for the selected number of categories:

Otherwise, the Participant will be removed from the list of LoveMed24 Championship finalists.

5. Due to the limited number of places, please consider qualifying to participate in the Championships, the deadline for registration and payment of fees within the specified period is decisive

6. A participant who has qualified for the LoveMed24 Championship is obliged to send his/her photo in order to create a graphic that will inform about qualifying for the LoveMed24 Championship, as well as for a personalized ticket.

7. The final decision on qualifying for the Polish Championships in a given category is made by the organizer.

CATEGORIES

1. NATURAL LIPS – the participant will perform a lip enlargement/shaping procedure with a natural final effect using any technique of their choice, participant has 1 hour to do this.

2. RUSSIAN LIPS – the participant will perform lip enlargement/shaping treatment within 1 hour.

The allowed number of participants is 15 people.

3. Full Face Volumetry, Male Volumetry - the participant will perform a treatment on various areas (lips, cheeks, chin, cheeks), and has an hour allocated for it. The allowed number of participants is 20 people.

4. NATURAL BEAUTY Metamorphosis of the Year - the participant, after registering and selecting a model, taking photos of the model's face from all sides without make-up, without retouching before starting the treatments, will perform a series of treatments of their choice at any time.

time so that the effect is spectacular but while maintaining the naturalness of the face. This competition is performed in the participants' offices, and the results will be announced at the "Winners Gala"

LoveMed24. Final photos must be sent no later than March 1, 2024. Category with no limit on places, application automatically qualifies for participation.

6. Creating a given category is obligatory depending on the number of participants, the minimum number of qualified participants is 5 finalists. If there will be fewer than 5 participants in a given competition, the competition will be canceled and, as a result, the participants will be refunded the fee paid for participation in the Championship in the nominal value.

5. COST OF PARTICIPATION

- 1 category PLN 1,000 (net)
- 2 categories PLN 1,500 (net)
- 3 categories PLN 2,000 (net)
- 4 categories PLN 2,500 (net)
- 5 categories PLN 3,000 (net)

In case of resignation from participation in the LoveMed24 Polish Championships, the fee is non-refundable.

PARTICIPANTS ARE REQUIRED TO PARTICIPATE IN THE CONGRESS AND PAY A FEE FOR IT.

EVALUATION CRITERIA

1. The submitted works will be assessed in terms of:

- shape,
- work aesthetics,
- migration of the preparation
- final effect

2. During the championship, the jury will evaluate:

- preparation of the workplace,
- occupational health and safety,
- preparation of the model
- treatment procedures
- application of the preparation (even distribution and at the appropriate depth) of the preparation in the tissue

- aesthetics and technique of work.
- Shape symmetries
- Difficulty of the procedure
- Level of a given technique
- Shape proportions of a given area

3. The jury will be appointed by the Organizer and announced on the website www.lovemed.pl and on social networking sites

The jurors will evaluate the works fairly, impartially and objectively.

4. The role of the Jury will be to evaluate the course of the procedure, hygiene and work safety, treatment procedures and the final effect in accordance with the assessment cards.

If the Jury notices any shortcomings that endanger life or possible complications related to the procedure due to unsafe techniques, applications, or failure to follow procedures, it may interrupt the procedure and exclude the participant from the championship in a given category.

5. The Supervisory Committee will supervise the work of the Jury and ensure the proper conduct of the above-mentioned procedures. The Supervisory Committee will consist of the organizer and 2 external persons appointed by the organizer.

The jury's assessment is final and cannot be appealed.

6. Only the person obliged to do so from the supervisory committee knows the results of the competition.

CHAMPIONSHIP RULES

1 Championship participants undertake to wear a white uniform/ apron/pants, as well as a white disposable protective apron and changeable footwear. Hair should be tied up and jewelry should not be worn. A disposable protective cap, a disposable face mask and disposable shoe covers are required.

2. The model is provided by the participant, the model should be dressed in black and should not have any special signs such as: e.g.; tattoos, dreadlocks, braids, green, pink, blue hair, earrings. The model cannot wear any jewelry. The model must have signed consent before the treatment, GDPR and consent to use the image in the form of photos and videos indefinitely.

The model must be of legal age and must not have any health contraindications to the procedure.

3. The final result will consist of the sum of points obtained from the Treatment Jury, which will be in the room before, during and after the procedure, and The General Jury, which will evaluate the models after the treatment and after the participants leave the treatment room.

4. Gentle make-up after the treatment, which does not affect the treatment area, and light application of a colorless moisturizing and polishing preparation to the lips is allowed.

6. The championship will be held according to the schedule, the participant is obliged to register one hour before the start of the championship. Registration will close 15 minutes before the start of the competition at the Championships.

7. The Organizer provides Participants with a treatment area in the form of: a bed, a chair, a treatment sheet, and an auxiliary table.
8. The organizer does not provide preparations, hygiene products, auxiliary tools, lighting or models.
9. During the Championships, the participant may not use a telephone, tablet, computer, take photos or listen to music, nor may he talk loudly.
10. Each Participant of the LoveMed'24 Championships is obliged to comply with the safety rules, occupational health and safety and fire protection regulations applicable at the facility where the Championships are held.
11. The organizer is not responsible for the model's lack of predisposition to perform the procedure.
12. The pre-treatment consent and health card of the model on the day of the Championships is completed by the model on the day of the procedure and the participant must have this card with him. Otherwise, there is a possibility of disqualification.
13. The model at the Championships will be wearing a black T-shirt and black pants and cannot wear any jewelry.
14. The model cannot wear makeup before the treatment, the facial skin must be disinfected.
15. Preparations used during the LoveMed Championships are optional, but must be certified and have a CE - European Certificate (preparation, not packaging)
16. The participant cannot have or use any anesthesia during the championships.

17. Models cannot have previously undergone lip enlargement surgery, during the championships the model's lips must be lips.
"virgin".

18. Models in the Full Face Volumetry category cannot have previously undergone volumetry treatments, already performed ones are allowed.
– enlarged lips, which will not be assessed by the Jury, therefore it is possible for the same model to participate in the lip and volume category.

19. During registration, the Participant is obliged to present a document with a photo, sign a consent to the use and publication of the image and sign the attendance list.

20. After completing the registration, the participant draws the number of the station at which he will perform the procedure. This number is assigned only to specific categories.

21. Each Participant will receive a personal diploma of participation in the Championship.

22. Models will additionally wear caps and disposable aprons.

23. Before and after the competition starts, a technical photo will be taken of the Model.

24. The participant starts working on the model after the Organizer announces the starting signal.

25. The Championship Participant and the Model may not leave the place where the Championships are held without the consent of the members of the Treatment Jury and the Organizer. In case of violation of this prohibition, the Participant may be disqualified.

26. After the information - signal of the end of a given category of the Championship, the Participant should immediately finish the procedure. The model should sit sideways on the bed after the treatment, and the participant should immediately clean his or her treatment station in accordance with hygiene and safety procedures. observing all precautions, sterilization and disinfection.

27. After the competition, the models will be taken, assisted by the organizer or his representative, to the room where the works will be assessed by the General Jury.

28. During the evaluation by the General Jury, the model cannot inform who performed the procedure and cannot talk about the participant of the championship. Otherwise, the participant will be disqualified.

29. The model should be assessed by all designated members of the General Jury.

30th Winners Gala

After the championships, the Winners Gala will be held, during which titles and certificates will be awarded.

Each participant is obliged to participate in the Winners Gala. The cost of participating in the Winners Gala is PLN 1,000.
